I am advised that the original of this form will be kept on file in the AYS office and if any changes to the above information needs to be made, it is my responsibility to contact the AYS office. In consideration of the services of the Town of Andover and Andover Youth Services, their agents, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (herein collectively referred to as AYS/Town of Andover.), I hereby agree to release, indemnify, and discharge, AYS/Town of Andover on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

- I understand there are numerous risks and dangers inherent in the sports of inline skating and skateboarding including but not limited to continually changing weather conditions and skating surface, ramps, bare ground, banks, boxes, equipment, fences, walls, and a multitude of other objects including this release. Further, I understand that there may be damage, personal injury, or death arising from my participation in the sports of skateboarding, inline skating and scootering.
- I acknowledge I have been given the opportunity and have been encouraged by the AYS/Town of Andover inspect the facilities/course PRIOR to signing this release.
